Minimum Qualifications:

- Demonstrate the ability to work in physically demanding environment for extended periods of time.
- The Ability to work in dark conditions and be exposed to theatrical special effects for extended periods of time i.e., strobe lights, fog machines, laser effects, and startle effects.
- Employees will be required to work evening hours of 5:30 pm to 2 am along with 12 noon to 4 pm on Sundays with the possibility of working more than an 8 hour shift in a day.
- The ability to withstand exposure to varying weather conditions/temperatures for extended periods of time.
- Have the ability to move 50-100 lbs. on a regular basis.
- Must be able to wear a costume/mask when required.
- Must be able to commit to working the majority of event show dates including any set-up and mandatory training dates.
- Ability to work as a team member.
- Enjoy Halloween type activities.
- Dedicated, have high energy.
- Must follow all safety regulations in and around the attraction.
- Must be 16 years of age to be considered for employment.

Requires satisfactory completion of the interview process and a successfully pass a criminal history background check.

1. Mandatory Training – September 28th
2. Dress Rehearsal- October 10th
3. Show Dates - October 11, 12, 17, 18, 19, 25, 26, 30, and 31 November 1st, 2nd Kids Bash October 20, 27
(*dates are subject to change*)

Summary of Work:

1. Employees will be responsible to the event director, state park manager and all park personnel in association with the Haunted Fork at Fort Abraham Lincoln.
2. Areas of work may include scene actors, make-up artist, Kids Bash staff, concessions/gift shop staff, ticket booth staff, and behind the scenes support staff.
3. Support staff in the ticket booth, q-line, staff area, and/or concessions.
4. Behinds the scenes support, in any of the three haunted attractions.
5. Provide general maintenance, set-up, teardown activities for the event.
6. Garbage collection and litter pickup.
