




**Question 1:** In the last year, how often have you or anyone in your household visited Fort Stevenson State Park?




Question 1b: If you don't visit or haven't come back, are there any reasons why?








**Question 3:** Which of the following best describes your primary reason for visiting Fort Stevenson State Park?



#### Question 4: Where do you usually get your information about Fort Stevenson State Park?




**Question 5:** In your average visit to Fort Stevenson State Park, which amenities or facilities do you and/or members of your household use? (Top 10 shown)









**Questions 29:** What price would you consider a one night stay at a full-service campsite to be a bargain - a great deal for the money?



**Questions 31:** What price would you consider a one night stay at a full-service campsite to be so expensive that you would not consider it?


**Questions 32:** What price would you consider a one night stay at a full-service campsite to be priced so low that you would feel the quality can't be very good?




Question 33: Please select the activities that you have done within the past year, if any.



**Questions 34 & 35:** To what extent do you agree with the following statements? "Fort Stevenson State Park..."



# Appendix C: Focus Group Key Themes Report



## Fort Stevenson State Park Master Plan Focus Group Key Themes Report

#### Introduction

This report summarizes the findings of four (4) focus group sessions conducted as a part of the 2021 Fort Stevenson State Park Master Plan public outreach approach. These sessions explored the perceptions of the park and needs of users from the point of view of the focus group participants. This information is used to supplement, enrich, amplify, flesh out or more fully understand the more quantitative findings.

The focus groups included individuals representing various park user groups, constituencies, partnering organization and local youth. Participants for the adult focus groups were selected and solicited by the North Dakota Parks and Recreation Department (NDPRD), while the youth focus group (Focus Group #4) was selected by staff from the Garrison Public School District.

The focus groups were conducted in April 2021 both virtually, using the Microsoft Teams conferencing platform, and in-person. Participants in the focus group were asked the same set of questions to identify the topics of convergence and consensus. The youth focus group questions were slightly modified to be more tailored for their perception.

The focus groups included:

Focus Group #1	2 participants
Focus Group #2	6 participants
Focus Group #3	5 participants
Focus Group #4	8 participants

It should be noted that the focus group methodology is qualitative and exploratory in nature and is not intended to provide data generalizable to a larger population. Focus groups are designed to elicit reactions from participants about a particular topic and to generate ideas and concepts that help increase understanding. The results from focus groups should never be considered representative of any larger population or target segment. The non-random method of selection and group size do not allow for this generalization.

This report was collated and summarized by an individual who is neither associated with, nor participated in the focus groups. The results are presented in terms of the "key themes" that emerged from questions asked regarding the current state of the park, desired state of the park and ideas for moving forward.

#### **Executive Summary**

Participants most frequently cited proximity to the park and water access (specifically to the lake) as the primary reasons for visiting the park. Access may include marinas, boating, kayaking, shore fishing or swimming. The parks proximity to Garrison and Minot provides convenient access to the physical and programming attributes of the park. Participants enjoy the ability to reach the park without lots of effort to get there. Other reasons include use of the trail system, different amenities that are offered like rentals or programs, events, and educational programming.

#### Ideal Visit

Being at the park is considered a place of respite to enjoy outdoor experiences that satisfy a sense of curiosity and increases a level of social connectedness on a year-round basis. Participants described the need for solitude and opportunities for camping, particularly primitive camping, as an enjoyable visit. Many also indicated that motorized and non-motorized boating is part of their ideal visit, which is not surprising given that water access is among their primary reasons for visiting. Ideal visits are desired in more than just the summer months. Participants were interested in winter activities and side season visits.

Since connecting with friends, family, and business endeavors is highly desirable, participants cited the need to for facilities for group gatherings is ideal. Specifically, they noted a consideration for facilities/amenities that support multi-generational needs.

Convenience was cited as a part of the respite experience. Participants desired to have access to food and drink concessions. It was noted that the concessions do not need to be a fixed service. Mobile services such as food trucks or other rotating services would heighten their visit.

The trail system is part of the ideal visit with multiple trail uses cited. Walking and hiking are primary users of the trail system, but there is a desire to have the ability for mountain biking, snowshoeing and equestrian uses.

It is desirable that all the activities in their ideal visit are supported with a variety of equipment rentals. The park may offer a great opportunity for those who cannot afford or wish to sample a variety of activities that require recreation equipment. The inventory of desired rentals includes kayaks, fat tire bikes, snowshoes, yard games and more.

Events and entertainment are key components to the experience at the park. Variety was key to drawing interest and return visits. Types of events included weekend entertainment and guided programs.

Participants most often said that their vision for the park's future is to sustain current operations. Participants seemed generally satisfied with the level of service being provided and the current efforts around creating clean, safe and friendly environment. Although, improvements to the trail system, particularly the trail surfacing, and wayfinding were two areas of opportunity with the trails system.

People were also interested increasing the variety of activities and offerings at the park. Variety of programming and activities is common when participants are frequent, repeat users of the park. They recognized the challenge to this is procuring better equipment or convenience activities, which require flexibility, expertise, and funding.

Participants also described their vision for the park as "robust," "active," and "a destination." This would include large events, expanded camping options with cabins or yurts and the addition of convenience amenities in food and beverage. A community building that can host family reunions or other large group gatherings was identified in the responses. These offerings are desirable all year around. Some participants noted that with the desire for an active park, considerations should be made to acquire lands for park expansion.

Fort Stevenson State Park is a place to be active in the outdoors. The importance of being physically active was equally matched with the mental health benefits of being at the park. The variety of activities is highly regarded, and many people like the rental equipment. Although they would like to see more variety in their offerings.

The programs and events are a draw for people to visit the park, creating a cultural experience and positive memories for many. This is further enhanced by friendly and helpful staff and facilities that people feel safe using. The positive memories and social interactions create traditions that become a source of stability in many people's lives.

Participants are keenly aware of the park's importance to the City of Garrison. Other participants, from Minot, also enjoy the park's offerings. This allows for both day use and overnight destination facilities. The addition of cabins and trails are well regarded along with complimentary scenery creates positive affirmations around the park.

Participants are keenly aware of the need for the park to provide inclusive and equitable access. Several responses were centered on improved accessibility for the mobility impaired. Examples included the store at the visitor center, improved trail surfacing and water access. Trail connectivity to the City of Garrison and the greater region, such as Garrison's Centennial Park.

Others indicated that they felt that most needs were being met, but continued focus on day use opportunities could continue as a draw for many people. Other needs included limited equestrian trails and health-based lifestyle programming.

Participated indicated that the access to enjoy outdoor environments is one of the most important functions of a state park (in general). State parks may provide a representation of a native landscape in flora and fauna. State parks provide opportunities to explore different regions of North Dakota and showcase local heritage, culture and legacy. State parks provide an experience that fosters familial and social relationships with inclusivity and equity. These positive experiences include accessing facilities that are clean, safe and in good repair. State parks should offer a variety of activities and programs with a digital campaign that includes upto-date marketing and advertising multiple digital platforms.

Specifically, at Fort Stevenson State Park, providing access to Lake Sakakawea is important. Participants cautioned to ensure that state park align available resources with public desires.

Participants expressed their concern to ensure the existing experiences, facilities, and programs are sustained. Sustaining public access for all socioeconomic demographics and people of all abilities. Beyond that, shoreline erosion and vegetation management are recognized as part of sustaining the park experience. Additionally, they noted the need for providing a variety of safe rental equipment to increase their experiences at the park. They recognized a potential need to improve telecommunications, particularly as many people now telecommute with COVID. Maintain the "hidden" infrastructure that the public does not see. Participant recognized that Fort Stevenson State Park may need to look at acquisition of adjacent property to facilitate future development.

- 6. Which populations, user groups or user needs are not currently being met at, or served by, Fort Stevenson State Park?

- Our group has one individual in a wheelchair, so having more accessible facilities (campsites, trails, even the buildings) would be good. The gift shop was pretty tight when we went in there the last time x3
- Any time you can make a trail more accessible for wheelchairs, you're also making it accessible for moms & dads with strollers, elderly, and people with trouble walking x3
- A member in our group has an electric, track-system wheelchair, so they can get around okay, but it requires being charged. So, making sure there's a location where they can plug it in would be good.
- We've been at the park as a group where we were all over the place doing a variety of activities, and our member in a wheelchair didn't feel as included in those activities because they couldn't access the spots where they were being held
- I don't really think there are any specific groups. I think it meets most groups' need as best it can, except for those with handicaps

- There's noting more frustrating to me than when a website hasn't been updated in year why would I go to a place that doesn't have current information or activities
- Provide opportunities for people to get outside and enjoy the outdoors x4
- Important that the park shows an accurate representation of what a native landscape looks like there. I think there's a lot of opportunity to showcase native prairie out there
- The trees are nice to keep, but they're not really part of our state
- To help those who camp or tent enjoy the outdoors and outdoor activities available in the state x4
- I think it's good for everybody to partake in what parks have to offer
- Provide access for folks to experience or explore the region, the grandeur of what the park has to offer x4
- To provide those folks perhaps less fortunate, or not able to move as well, an opportunity enjoy the outdoors too
- To provide a clean and safe place for families to experience and enjoy nature. It's challenging when you go to an unmanaged place that's nice until a group of drinkers turns the area into a frat party that doesn't happen at Fort Stevenson. That's the nice thing about Fort Stevenson I don't have to worry about those other safety/maintenance challenges
- I think Fort Stevenson has knocked it out of the park in being safe and friendly
- I feel that it's to create an environment where you bring families and nature the best you can in a friendly safe way, and grow that relationship as much as you can

- Safety of equipment (e.g. Trooper's challenge equipment isn't great). Maybe partner with someone in town to revamp that and allow the whole family to engage with each other
- Can the marinas support future/continued growth? Are we ready for it?
- Can the park support more growth? I think it works now, but what about into the future
- Increase telecommunications belongs at park, but I'm not sure that'd I'd use it all that much. There definitely is a high interest in this especially with people telecommuting these days.

- Not overdoing technology. There's a crowd that needs it and it's only going to increase, but also recognizing that there's an outdoor experience to do
- 10. What suggestions do you have for the North Dakota State Parks & Recreation Department as it develops the 2021 Fort Stevenson State Park Master Plan?
  - Continuing to support them in their endeavors of being as diversified as they can be
  - I just hope that the Department recognizes that Fort Stevenson has reached a vision of being diverse, and I hope that's supported.
  - I don't think this means everything has to be offered (like horses), but the park supports a lot of unique introduction-type recreation offerings.
  - It's a great family vacation without having to leave the state. You can do a lot of things without leaving the park it's all right there
  - Recognize that you do have parks that are very specialized, but we need those parks that provide a lot of variety.
  - Allow the parks that do provide diversity the ability to sustain it.
  - If you're really looking at an idea to get the most out of the park, I think resources are best spent towards accessibility
  - Maybe a trail that is more paved, less rugged?
  - Maybe less dogs on the trail or trail designated for no dogs?
  - An indoor location to retreat or use for bad weather days would be good x4
    - If you do that, make sure it fits with the theme of the park and isn't "dorky"
  - Explore a route between the park and town
  - Apply for federal dollars to help implement some of the ideas (e.g. FLAP grant). Maybe this can be used to increase accessibility of the trails
  - These last few years, I think the department has done a great job of listening to the citizens in what they want in their state park. "We no longer have to break legs to get the ear of someone." Just keep doing that.
  - Think big
  - Broaden user groups beyond campers and fishermen
  - With COVID, we're in a time where we don't need to necessarily build away to attract people. They're ready to get out of the house and do somethings. So, I'd want to focus on maintaining what we have first. I'm not saying there isn't a natural progression/expansion of the park, but I'm not sure we need to focus our attention on pushing development forward immediately
  - Maybe focus on meeting the spatial needs of what people are bringing into the park more toys
  - I think this strategy of engaging focus groups is great keep doing that
  - Think about all the park. Not just the physical infrastructure and resources. Think about the business of the park and things like that (all facets of the park)
